**FROM THE QUARTERDECK**

We were fortunate to enjoy a splendid Blessing of the Fleet and Opening Day ceremony and our spirits were buoyed by the turnout of over

160 people for cocktails and dinner. Credit goes to Jon Moody and Mike Calkins who managed the event so expertly. The Offshore Division had a large turnout for two days of sailing in shifting conditions, under supervision of a great Race Committee, headed by Brooks Zerkel. So, we are off to another year!

As we move past our season opening, we will be almost halfway through our fiscal year as you read this. Accordingly, it seems appropriate to devote this column to a brief review of the Club's condition as we weather the current economic storm, and to focus on the key ingredients to our success: prudent management of our assets and maintaining our membership.

As of March 31, our revenue and expenses were at or near budget with the most significant variance for alterations to the water system to meet the deteriorating quality of our well water, and, to a lesser degree, increased expenses in the publication of the color log, exacerbated by a slight decline in advertising sales. These were largely offset by a favorable variance in interest expense as a result of the scheduled reductions in our loan balance last year, and accelerated by substantial payments this year, made early to keep our bank cash balance under the amount insured by the FDIC. Many thanks to our finan-

cial leaders Chip Hall and Mason Chapman for keeping a close eye on the deleveraging process. Our physical assets are in good shape, although we have postponed the last capital improvement to the creek-side bulkhead until next year to conserve cash. One temporary discrepancy this weekend was the pool, which is in the process of being relined, after the recent work delaminated. Happily, the contractor is absorbing most of that cost, with the club paying only for materials. Also, the new concrete floor in the pool pump house will be completed soon, so the unsightly dismantled equipment now stored in Ric's Place, the pool pavilion, will be out of the way.

The key to the Club's financial health and vibrancy is sustenance of our membership levels in times when increased attrition might be expected. We have been focused intently on this the last few years, particularly through the current renewal season. We are pleased that the efforts are paying dividends. Despite challenging conditions, this year's resignations to date (22) are up only slightly over the median (20) and right at the mean (22) for the last 8 years. In that same period, the recruitment of new members offset the resignations, with a median (21) and mean (22). These numbers understate the effort and success of our Membership Committee efforts, however, because successful recruitment had to offset the zenith of resignations in 2005 (31) following a dues increase, and nadir of recruitment (10) that same year following an initiation fee increase. Since 2005, the trend of new members has been up materially each year (16, 17, 22) and the quality of the new members has been terrific. If 2005 were eliminated as an "outlier",

then our current performance would be right in line with the past average, but just short of our upward trend. This success can be attributed directly to the determined efforts of George Burke's Membership Committee, with support from Mary Spencer, which actively manages a list of prospective member "leads", helps strangers with marked sailing potential meet potential sponsors, and keeps the process moving with regular membership meetings. To date this year, we have a head start on new members with final approval (11) and have a number of other qualified candidates (5) at various stages in the process for an encouraging total (16). So we are doing very well at this point, having reached both the median and mean of the last eight years, but still falling well short of the top of the trend for new members in the last three years, culminating in 2008 (22); so we need to remain focused to keep our pace.

With George's leadership, the new processes in place, and continued focus and effort, we should be able to sustain our recent successes. We hope every member will be attuned to new expressions of membership interest. George and Mary are standing by to process those applications efficiently, and where necessary, George can assist in the recruitment of sponsors and persons who have met the applicant. The membership meeting takes only a couple of hours, generally on a Tuesday night, and is, in itself, a very pleasant gathering, as now conducted by George's committee. Hopefully, each member will be motivated to renew their efforts at membership recruitment, the lifeblood of our sport and FBYC.

Meeting called to order at 6:05 p.m. by Commodore Noel Clinard.

**REAR COMMODORE – DAVID S. HINCKLE**

**SECRETARY** – George Burke reported that as of today, there are nine members who will receive certified letters because they have not paid their 2009 dues/fees.

**HOUSE** – The east bath house bathrooms have been painted, exhaust fans for the showers have been ordered and privacy shower curtains will also be added after the fans are installed. Ken Odell will have the broken window in the barn locker area replaced.

**DOCKS** – The slips are fully rented and there are nine boats on the waiting list. There are two dry sail parking spots available. Tom O’Connell reported that the Fishing Bay long-term dock planning committee will hold its next meeting on April 21.

**HISTORIAN** – Jere Dennison reported that he is ready to place the order for the donor plaque.

**OPERATIONS MANAGER** – Dixon Cole reported that solar-powered walk lights have been installed on the pump-out dock, the water and pump-out equipment has been reinstalled and is working, the ladders are installed, and the dock light bulbs will be replaced before Opening Day. The Fishing Bay parking area has had bollards set and scraped. The plastering company has removed loose plaster in the pool, the railing company has ordered replacement caps

for the posts around the pool that have problems, measurements will be taken for a quote on the railing that remains to be replaced, and the concrete in the pool filter room will be poured before the end of May. Spring cleaning is on schedule and the east bath house and the Fishing Bay clubhouse stairwell doors have been painted. Insofar as the problem with obtaining an adequate water supply from the club’s well is concerned, an application for a permit for a back-up well was submitted to the County on April 6 and we should have an answer in about a month. Club members have received a notice asking that they be as frugal with their water usage as possible. The septic tanks have been pumped out.

**VICE COMMODORE – C. MAYO TABB, JR.**

**FLEET CAPTAIN** – Allan Heyward reported that the Coast Guard permits were issued individually this year and they have been received. A capacity crowd attended the Racing Rules Seminar. There were 28 people registered for crew training classes and about 10 per day showed up for the on-the-water training days that took place on three offshore boats. Revenue from the Racing Rules Seminar and crew training covered expenses and the additional revenue paid for the training manuals.

**OFFSHORE DIVISION** – Alex Alvis reported that a notice will appear on the web site pertaining to the requirement to obtain PHRF Certificates. Boats without valid PHRF Certificates

are not eligible to race. Brad Miller advised that there are new race forms that should make it easier for the race committees and for the JAVA scoring. He will contact the Social Chairs for the Spring Series to remind them of their duty dates.

**ONE DESIGN DIVISION** – Junior Opti racers will be encouraged to race in the Spring and Fall Series. In order to have a PRO available for a separate start for the Optis, Matt Braun advised that they will be asked to register a couple of weeks ahead of each race.

**CRUISING DIVISION** – The Welcome Cruisers social took place on March 28 with 33 attending. The events scheduled for May include the Mathews Yacht Club Cruise on May 16-17, the FBYC to Urbanna trip on May 23, and the After Rosegill Cruise to Yankee Point Yacht Club on May 24-25.

**JUNIOR DIVISION** – Jay Buhl has actively started marketing OptiKids, Junior Week and the Junior Racing Programs. He has received great response from the use of notices to [juniorsailing@fbyc.net](mailto:juniorsailing@fbyc.net). The junior apparel designs for Junior Week tees, race tees, junior polos and Junior Week polos have been finalized and inventory ordered. Opti Team Trials will be held in Connecticut the first week of May and six FBYC juniors will participate.

**FLEET LT.** – Jim Poindexter and Dixon worked on the props for *Mr. Roberts* and later in the season, they will have a diver clean them again.

**FBYC BOARD HIGHLIGHTS (CONT)**

**SAILING FLEET LT.** – Joe Roos has completed the inventory of the Opti, Laser and 420 fleets. The 420's are now being used for high school sailing. Joe will begin work on the Optis and Lasers with a goal of completing any needed work by June.

**PROTEST** – Brooks Zerkel reported that there was a good turnout for the Protest Seminar. He has ordered horns

for the committee boat but they will not arrive by Opening Day. He has the protest worksheet forms ready for use.

**CBYRA DELEGATE** – Tom Roberts is ready to start CBYRA PHRF High Point Scoring for the sailing season and will provide periodic updates and final results upon completion of the last race of the season. The most recent of three Jackson Creek Surveys (December

2008) has been published and Tom has posted prints on the bulletin board outside Fannie's House. Tom has prepared an article for the Log that will also be posted on the web site relating to Corps of Engineers surveys of Jackson Creek and other creeks on the Chesapeake Bay.

There being no additional business, the meeting was adjourned at 6:50 p.m.

## In Memoriam

*ALLEN B. FINE*

*3/19/1926 – 3/29/2009*

Allen B. Fine, 83, died suddenly on March 29, 2009. He is survived by his wife of 57 years, Isabel Truslow Fine; daughter, Allyn Fine Linas; five grandchildren; and two great-granddaughters. Allen served in the U.S. Army during WWII on recovery boats in Brownsville, TX. He then entered the Georgia Institute of Technology and it was there that he met Isabel. They were married in 1951 after their graduation. Allen and Isabel joined Fishing Bay Yacht Club in 1970 and were elected to Life Membership in 1992. He and Bill Harding were partners in *Chasseur*, a Newport 27. It was early in their partnership when they were the recipients of the infamous Piankatank Trophy. Bill Harding doesn't recall exactly what occurred to get them nominated for that perpetual trophy but thinks they ran aground near Stove Point during a night race and both were "mortified" about the incident. On a trip to the Annapolis Boat Show one year, Allen, Bill Harding, Mason Smith and Paul Middleton decided to buy a Carter 33, thereby forming the Stingray Syndicate. The first initials of the four wives were to be used in naming the boat. Their choices were *AVID* and *DIVA* and they ultimately decided on the name *AVID*. That partnership lasted until the late 1970's and Allen then acquired a J-24 for several years. Allen preferred to have someone else skipper his boats and the skippers of choice for the J-24 were Drew Sinnickson and Tommy Call. His next boat was *Sleighbelle*, an Olsen 30 that he owned until about 1988. Drew Sinnickson was dispatched to California for this boat, which he hauled across the United States to Deltaville. Drew, Tommy or the late Chip Brierre skippered *Sleighbelle*. Allen attached a pair of sleighbells to the boom of the boat and the noise they made when the boat was tacking warned all other boats of *Sleighbelle's* location. He raced in the Olsen 30 National Championships for a number of years, resulting in one 1<sup>st</sup> place finish and two 3<sup>rd</sup> place finishes. With his sailing years behind him, Allen turned to powerboats and fast cars. He also enjoyed flying his planes and sailplanes and was a founder and president of the Virginia Motor Sport Club and a member of the Richmond Ski Club. Allen loved the water, boats and fishing and all were available from their cottage overlooking the Piankatank River. During his years in FBYC, he served on the Board as: Trophy Chair 1974, Log Streamer 1975, Secretary 1976, Fleet Captain 1977, Rear Commodore 1978, Vice Commodore 1979, Commodore 1980, and Member-at-Large 1981. In 1985, Allen presented the Allen B. Fine Trophy to the club. This perpetual trophy is awarded to the outstanding crewman of a Fishing Bay Yacht Club enrolled yacht each year. ### Sailing Fast at Sailfest

Kyle and Kendall Swenson flew down to Sarasota, Florida for the Sailfest Regatta March 28-29. This regatta attracted 155 boats and could have been more aptly named "Sailfast" as a frontal system moved through the first day with winds gusting to 35. The only class that completed a race on Day 1 was the Optimists because they started their racing earlier than the other fleets. Even then, only seven of the 30 competitors were able to finish as the front approached the racing area. Meanwhile, on the Laser Radial course, the sailors were enjoying the planing conditions in the building breeze that produced 3-4 foot waves. As the leaders got close to the weather mark they discovered the wind literally blew the marks away, forcing the race committee to abandon racing for the rest of the day. Conditions were a lot more favorable on Sunday. The breeze had moderated to 10-12 knots and the RC was able to complete three races for the Optimists and two races for the Radial class. Kendall finished 8th out of a fleet of 49 Optimists, third in Blue Fleet, and Kyle finished 5th out of 30 Radials.

## JACKSON CREEK SURVEY

Want to see a recent Corps of Engineers survey of Jackson Creek or other creeks on the Chesapeake Bay? The Norfolk District of the Corps now publishes their recent surveys. There are actually three recent surveys on the Jackson Creek channel; July 25, 2005; August 20, 2006 and December 30, 2008. The later was just published in February. The website is <http://rci.nao.usace.army.mil/esds/index.asp?page=home>.

You will need to register and download a free AutoCAD DWF viewer which is provided through the Corps web page. Once you are set up, you can select the creek and view most recent and archived reports and drawings. You can zoom in to see details. As most of us know, the narrow and shallow spot is between Daybeacon 3 and 5 right in the bend. The number of surveys indicate the Corp is watching this closely and hopefully will be able to return it to its authorized depths and widths.

Middlesex County has made dredging Broad Creek their #1 priority for projects submitted for stimulus money. Apparently that project has been planned, has a designated spoil area and is "shovel ready". There is a request for dredging in Jackson Creek, however it is not well developed and it is only for a turn-around area near the Maritime Museum. ## **SMALL BOATS, TRAILERS, GRASS AND MOWER**

If you have a small boat on a trailer or dolly, parked in one of the grass areas in the one-design lot or in front of the main clubhouse, please make sure that your tires are properly inflated and the trailer or dolly is in serviceable condition so that it can easily be moved. Approximately every two weeks, Dixon Cole has to move all of the boats parked in the grass areas in order to allow for our lawn-care contractor to cut the grass at the club.

Also, please insure that your boats that are stored on trailers or dollies are shipshape, with all spars, rigging, lines and other gear stored and secured inside the boat. Covers, if used, should be fitted to the boat and properly tied down. Tarpaulins are not allowed. No parts or equipment should be left on the ground under or around the boats, as we cannot hold our lawn-care contractor responsible for damage to property or equipment left on the ground.

## FIREBALL AND FRIENDS 2009 DIYC

March 11-15, Davis Island Yacht club hosted the 2009 Fireball and Friends as a Mid Winter ritual that FBYC's Front Runner Class has attended for 11 consecutive years. If any member detects a water leak anywhere, docks, bathhouses or kitchen, please let Dixon know immediately. While it is true we have a large storage tank, one running toilet can drain it surprisingly fast. Of course we can still use the bathrooms, take showers and wash our boats, we simply cannot be wasteful. Thank you for your help during this temporary situation.

I would like to publicly thank Wes Jones, Ken Odell, and Dixon for the many hours each of them have dedicated to resolving this problem. Thank you all.

## **LEUKEMIA CUP SEASON OPENS IN MAY**

The 2<sup>nd</sup> decade of Southern Chesapeake Leukemia Cup activities commences in May. On-the-water events include the Junior Regatta Challenge at Christ Church School and the Kayak Tour at the Deltaville Maritime Museum. These two important events herald Art on Fishing Bay and the Junior Sail-A-Thon to follow in June and the One Design Challenge and the grand finale Auction, Regatta, and Gala to be held in July, all of which will be hosted in Deltaville at the Fishing Bay Yacht Club.

Over the first ten years of its existence, more than \$1.7 million has been raised, making this Leukemia Cup one of the most successful in the nation. In 2008, the Deltaville event was named the sixth top fundraiser out of 38 Leukemia Cup Regattas nationwide, the majority of which are held in more populous areas of the country. Also in 2008, Deltaville native Carolyn Schmalenberger, co-chair of the event, was designated the 7<sup>th</sup> highest individual fund-raiser in the country for all Leukemia Cup Regattas.

### **The Kayak Tour**

The Kayak Tour repeats this year at the Deltaville Maritime Museum and Holly Point Nature Park from 9am to 12 noon on Saturday, May 9.
