Easter Week End. The J-29 Invitational Regatta was held and, despite the bad weather on Friday, the racing on Saturday and Sunday



Daniel Lee Austin, 5976 Old Greenway Drive, Glen Allen, VA, 23059, died on April 23, 2003. His wife Stuart; his two daughters and their husbands, Laura and John Howard and Amy and Dan Ludwin; and four grandchildren survive him.

Danny had been a member of Fishing Bay Yacht Club since May 1972. He served on the FBYC Board as Log Streamer (1980), Secretary (1981) and Offshore Division Commander (1999). An avid racing and cruising sailor, Danny was once the owner of a 505, a Pearson 35, a J-24 (*Jaded Lady*), a Presto 34 (*Present Mirth*) and a J-105 (*Dark Star*). In more recent years, he raced a Flying Scot on

Board Meeting Highlights

April 8, 2003

Meeting called to order at 6:05 p.m. by Commodore Dick Cole.

SECRETARY – Elizabeth Staas reported that there are 10 delinquent members and a certified letter will be mailed to any member still delinquent as of April 11.

The Membership Report lists those who have applied for membership and who attended a membership meeting on April 7, 2003. The Chapmans came in under the old rules and were voted into circula-

tion. Elizabeth explained in detail the guideline procedures now in place for the remaining applicants whose membership applications have been received since the first of the year. The Membership Committee recommended that these applications be accepted and the applicants be placed on the waiting list. Following the new Membership Guidelines, the Membership Committee will consider each applicant and determine at a later date when and if they should be presented to the Board for a membership vote.

HOUSE – Lud Kimbrough talked about the different keys used in the Club's facilities, where they work and how they are obtained. Keys are not to be duplicated. He is having some instruction signs prepared to post in the clubhouses because members are not always turning off the fireplaces or locking the doors when they leave. Lud reported that he has also standardized the storage system for all supplies. A protest room and an office have been prepared upstairs in the main clubhouse.

DOCKS – Gil Miles reported that we have slips available but all of the boats on the waiting list are too large for existing vacant slips. Gil discussed the ongoing talks with the consultant about the wet slip construction application as well as the bulkhead permit and maintenance dredging. Fire extinguishers on each pier on Jackson Creek have been inspected. He has also determined the location of other fire extinguishers on the property and where fire extinguishers need to be added.

GROUNDS – Approximately 47 people showed up for Spring Clean-Up day. At least 17 of the volunteers are members who have joined in the past year.

WEBMASTER—Strother Scott – Strother reported that the member-managed mailing lists seem to be working pretty well.

VICE COMMODORE—DAVID HAZLEHURST

OFFSHORE DIVISION – The JavaScore program does not support some of the scoring guidelines for Off-

shore as requested by CBYRA, and Randy Alley has been advised that it is not a good idea to try to customize the program. An amendment in the sailing instructions for Offshore was prepared following the regular Board meeting.

ONE-DESIGN DIVISION – John Beery reported that two classroom and two on-the-water training seminars have been completed. On April 6, 40 people attended the Flying Scot seminar that featured Greg Fisher of North Sails. Five different yacht clubs were represented.

CRUISING DIVISION - The first cruising event will be held at Fannie's House on April 19.

JUNIOR DIVISION – Ruthanna Jenkins has received 56 paid registrations to date for OptiKids/Junior Week. Eight juniors have signed up for the 420's. Kelly O'Toole has planned the social activities and Jan Monnier is recruiting instructors for the regular Junior Week program. The CIT's will have a training session prior to Junior Week. Housing for the Junior Coach is now available.

FLEET LT. – Paul Howle reported that Paul Andersen has completed repairs on one of the club's 420's. Any member interested in learning how to operate *Mr. Roberts* should contact Paul Howle. Don Landau has volunteered to operate *Mr. Roberts* during the Spring Series Offshore races, a welcome assist for Race Committee Chairs.

TROPHIES – Beginning this season, there will be a sign-out sheet for all trophies taken out of the computer room that are to be given out at the end of each race day. Also, Debbie Cycotte will have glasses to be given to the Race Committee and Social Chair for each race day as tokens of the club's appreciation for their efforts.

OLD BUSINESS – Dick Cole reported that the committee working on plans for the Fishing Bay waterfront and dock has met several times and is getting close to having something to present to the Board. Their current objective is to do this no later than the May Board

loan to him from other club members and enthusiastically took up kayaking to explore the thinner waters on lakes, rivers, and tributaries of the Chesapeake Bay. Additionally, his maritime travels included chartering boats in Alaska, the Virgin Islands, and Florida Bay.



Perhaps his foremost sailing accomplishment was to realize the dream that many of us

have had but that few will ever experience. In the mid-1970's, he took a sabbatical from his career, sold his home in Richmond, and headed south to spend a year in the Bahamas with his first wife, Robin, and his two school-age daughters on their Pearson 35. Their ultimate destination eventually became Georgetown on the Great Exuma Island where a pleasant winter was spent exploring beaches fringed by tropical palms and scoured by ceaseless tradewinds.

Danny always fantasized about an extended encore trip to the southern climes. It didn't happen again in this life, but perhaps even now he is donning his mask, snorkel, and flippers on some balmy ethereal beach to eternally explore a deep blue, celestial sea.



**Safety First:
USCG Courtesy Safety Checks
Scheduled for May 10, 2003**

Those of us with PHRF ratings annually inventory our safety equipment to make sure we comply with PHRF requirements, but how recently have any of us done a comprehensive review of our cruising/offshore racing boat's safety preparedness? How many of us know for sure what the Coast Guard would say about our compliance with safety and federal requirements?

Dick Curtiss has volunteered to line up USCG personnel to provide courtesy safety inspections at the Jackson Creek docks on May 10, 2003. If there is more demand than can be met in one day, a second day will be arranged.

Those found to meet Coast Guard standards will be entitled to display a Vessel Safety Check decal issued by the inspectors. Those found wanting will suffer no penalty and will get a free primer on what needs to be done to get up to snuff. All skippers will benefit from the time taken to concentrate on safety issues and preparedness.

Your Historian is taking a break this month from writing club history but instead will report briefly on what is happening with regard to our archives. Mac Wellford, a Club founder and Historian for most of our existence, carefully preserved records from 1939 through 1991. After Mac's death, Wayland Rennie collected these records and has stored them at his house for many years. **The FBYC Long Range Planning
Process**

This winter, Commodore Dick Cole requested that I convene a Long Range Planning Committee to establish a blueprint for the next ten years. His objective is to assure that in the years to come the club meets the needs of all members—including juniors, one design racers, offshore racers, cruisers and others. The intent is to provide a quality yacht club at a reasonable cost.

Recently, funding for our splendid clubhouse came 40% from member contributions, 40% from cash reserves and 20% from debt. But the incredibly generous contributions were most likely a once in a lifetime occurrence, and debt should not be a routine method to finance a club. Therefore, Commodore Cole has wisely asked for a plan that would anticipate our future financial requirements. Accordingly, based on our blueprint, the Committee will develop a 10 year business plan which will guide your Board in making operational and financial decisions.

A key feature of any long range plan is flexibility. We intend to produce a living document, one that is dynamic and may change as circumstances dictate.

Our 10 person committee (plus Flag Officers) has had 3 meetings, primarily focused on describing what we would like our Club to be in the

New Membership Guidelines

As a reminder, FBYC new Membership Guidelines went into effect January 2003. The new procedures allow our FBYC Board and current members more time to get to know prospective members before voting them into membership. FBYC always encourages members and non-members to participate in our Off-shore Racing, One-Design Racing and Cruising Events. Non-member children are also encouraged to participate in any of the above and, of course, Junior Racing. As you know, FBYC is always seeking new members who will help promote our sailing and cruising programs to their highest scale; however, the club currently has a Waiting List for Membership.

If you are planning on sponsoring a prospective member, please contact Elizabeth Staas, Membership Chair at 278-9882 to discuss the applicant. You, as a sponsor will then be sent an application to forward to the applicant for completion. As primary sponsor, you are responsible for gathering all appropriate documentation and submitting it with the completed application to Mary Spencer, FBYC Secretary. The sponsors (2) must be FBYC members in good standing and have joined FBYC prior to 1/01/03. FBYC members who have joined after 1/01/03 must be members for 4 years before sponsoring an applicant.

Applications are reviewed and subsequent membership meetings may be held once per quarter. Applicants are interviewed by the Membership Committee and then the committee determines whether to place the candidate on the waiting list or reject the application. As deemed appropriate, candidates on the waiting list may be presented to the Board of Trustees to be voted

into membership. The names on the waiting list are not published; however, all are presented to the Board at each Board Meeting.

Anyone wanting a copy of the membership guidelines should send a request to Elizabeth Staas, Membership Chair. Any questions or comments should be referred to the Membership Chair or the Membership Committee. The 2003 FBYC Membership Committee consists of Elizabeth Staas, Chair; David Hazlehurst, Jay Buhl, Mason Chapman and Allan Heyward.
