



FROM THE QUARTERDECK

JUNE 2010



The season started off with a great Opening Day event and dinner. This year there were five scheduled weekends of sailing that were reduced to four due to near gale wind condition. The series was almost entirely heavy weather sailing with number threes. **Strother Scott's** *Loose Cannon*, **Eric Power's** *Nereid*, **Brad Miller's** *Schiehallion* and **Dick Cole's** *Nutcracker* took PHRF A, B, C and Non-Spin respectively. When sail-

ing on *Double Eagle*, we saw 10.2 knots on the knotmeter under spinnaker on the last day of sailing, which was truly an exciting day of sailing.

In the middle of our Spring Series, a growing number of FBYC sailors were making the trip to Annapolis for the NOOD with FBYC members sailing on six boats. The National Offshore One Design Championship is truly an outstanding event with completion at the highest level with nearly 250 offshore yachts from around the county and overseas competing in 20 classes over four separate racecourses. The race management was exceptional and use of radio communication was appreciated by all competitors and eliminated any chance for confusion as to courses or starting sequence. It is something we should seriously consider using starting with our larger regattas such as Leukemia Cup and Stingray. **Cyane, Marie and Will Crump**, with crew **Scott Collins**, obtained FBYC's best result by sailing their J-105 *She Crab Soup* to fifth out of a very competitive 28-boat J-105 fleet, including boats from Canada. The J-105s jostled at the start as if they were racing Opti's and routinely the "India" flag was shown to those over early. In addition to the J-105s, there were J-80s, J-30s and Melges so you had 85 offshore boats on the course and somehow they all ended up at the leeward mark so the roundings were very exciting as the lead boats rounded within seconds of each other. Having two downwind gate marks added to the tactical challenge as you had to decide which one to go for to do your downwind spinnaker douse. Their competition included **Drake Johnstone** and **Clark Dennison** crewing on competing J-105s. **Sam Mitchener**, with a

near all-FBYC crew of **Carrie Russell, Scott Turpin, Mark Stephens** and myself along with **Melissa Orndorff** and **Bonnie Black**, started off great the first day putting *Double Eagle* first around the weather mark in two races but unfortunately our performance faded afterwards. We all left feeling this was the best regatta we had sailed in and learned a lot competing with J-109s from the New England to the Carolinas. **Chris Jankowski** sailed his J-24 to 8th in the 17 boat fleet after previously taking it to a third place in the Charleston Race Week. At the top of the fleet, FBYC's **John Dodge** did foredeck on the near professional Farr 40 Class. Those boats are really fast and typically lapped us on a 2-lap racecourse. After the first day, we quickly learned that the only way to deal with a Farr 40 on the race course was simply to get out of their way!

The planning and all the behind the scenes work is the key to the successfully programs we have here at FBYC and this has been a very busy spring. The work is almost complete as we shortly will have a sold out Junior Week followed by Leukemia Cup, Opti Nationals and competing in the NYCC Invitational. **Jay Buhl** and **Noel Clinard** have done an outstanding job with a huge team of volunteers in pulling together the Opti Nationals to be held in July for 350+ young sailors from all over the country that with parents, coaches and support personnel could result in over a 1,000 visitors to Deltaville for the Regatta. The support from the Deltaville community has been outstanding and this could easily be the largest event ever in Deltaville. The regatta should have a significant positive financial impact on local businesses supporting that many guests for the week-long event. **Jon Deutsch** has created an outstanding Opti Nationals web site with everything about the event that can be reached from a link on the FBYC site.

Joe Schott got the Cruising Program off with an excellent all day Safety-at-Sea Seminar that included talks about Marine Electronics, offshore communication, handling medical emergencies at sea and a presentation by the USCG on rescue methods. This seminar was attended by over 30 cruisers and we all left more informed about the many aspects you need to know to cruise offshore. The cruisers have a full schedule of long and short cruises along with social events so I hope many will take the opportunity to enjoy this aspect of sailing.

Meeting called to order at 6:00 p.m. by Commodore Mayo Tabb

REAR COMMODORE – ALEXANDER ALVIS, III

HOUSE – **George Burke** reported that the resurfacing of the decks and porches upstairs in the main clubhouse has been completed and the external signage for the club is being renovated. George is keeping a close check on an a/c problem in Fannie's House.

DOCKS – **Mike Dale** reported that Dixon has all of the electrical outlets working on the docks. The Special Docks Committee meeting originally scheduled for May 17 has been postponed to June 14.

SOCIAL – **Michael Calkins** reported that there were approximately 160 people in attendance for the social event on Opening Day. Rosegill is the next large social event and it will be family picnic style.

GROUNDS – **Ken Odell** expects the pool to open on time.

LONG RANGE PLANNING – **Lud Kimbrough** has recruited **Philip Halsey** as head coach for the YMCA camp this summer and there are already 16 signed up. This is a very positive trend in sailing interest in the community. Lud has completed briefing documents about the New York Yacht Club Invitational Challenge series and will begin sending them to members and potential sponsors.

WEB MASTER – **Strother Scott** reported that **Jon Deutsch** has been working with **Mary Spencer** in trying to solve some long standing issues relating to the cut-off restrictions on the number of recipients who receive club notices within a specific period of time. He and Jon should find a new and better emailing system in the coming weeks.

HISTORIAN – **Jere Dennison** advised that the donor plaque may be ready in a couple more weeks.

OPERATIONS MANAGER – **Dixon Cole** is getting all of the boats ready for Junior Week and he has re-installed the rails around the deck in the main clubhouse.

VICE COMMODORE – DAVID S. HINCKLE – **David Hinckle** advised that because the Fleet Captain is the club's safety officer, **Tom O'Connell** will have authority over the lifeguards hired by the club for the summer.

FLEET CAPTAIN – **Tom O'Connell** presented changes to the Pool Rules that, upon motion duly made and seconded, the Board approved. The new Pool Rules can be found elsewhere in the Log. **David Hinckle** advised that the club will purchase a lifeguard stand for the pool area. A booklet for the lifeguards outlining their duties has been prepared. **Tom, Dixon Cole** and **Alex Alvis** plan to meet with the lifeguards and will go over their duties with them.

OFFSHORE DIVISION – There is one more Spring Series race scheduled for May 15. The May 8 Spring Series races had to be called off because of the weather.

ONE DESIGN DIVISION – **Matt Braun** reported that two one design races have been held – Opening Day and Spring Series #1. There are three more one design Spring Series races scheduled.

CRUISING DIVISION – **Joe Schott** reported that there were 10 boats and 32 participants in the shakedown cruise to Mathews Yacht Club. There are eight boats signed up for the first Captain's Choice Cruise, which will be to Onancock if weather permits. There are currently eight boats registered for the Delmarva Cruise with two additional boats meeting them in the upper Bay. Joe sent a "Cruising News" email to the club's cruisers reporting on cruising events. He has also encouraged cruisers to sign up for Rosegill.

JUNIOR DIVISION – **Jay Buhl** reported that the number of OptiKids was increased from 32 to 34. He needs at least six more Optis for use during Junior Week. The Race Teams' travel schedules have been finalized. Junior coaches arrive on June 11. The second semester of high school sailing being sponsored by Fishing Bay will be completed with an event at Christchurch School. The Laser Radial Clinic held at Hampton Yacht Club has also been completed. Jay urged Board members to check out the Opti Nationals 2010 web site. Registration is now open as is the Opti Nationals Store. Jay thanked Layline for a Platinum Sponsorship for the USODA Nationals. He still needs volunteers to serve in a number of areas. Jay also gave updates about the New York Yacht Club Invitational Challenge. **Noel Clinard** trailered a Sonar from New York and it is now at the club. Jay is

coordinating the training effort and there are approximately 25 people who have expressed an interest in crewing for FBYC. The changes presented by John reflect the procedures that are now followed. By motion duly made and seconded, the changes presented were approved by the Board.

Hurricane Season is Here

April showers might bring May flowers, but June brings the beginning of the annual Hurricane Season, which is a good time to review a few of the Pier Rules. But, thinking back to the November Nor'easter, just a few months ago, reminds us that we don't need a named hurricane to cause us problems.

Dock lines must be of the proper size and strength for the boat that is being secured. They must be kept in good condition and should they start to develop areas of chafe, they must be replaced immediately. Also, dock lines attached to the dock must be attached in such a way that they can be adjusted from the pier in case of high water. It is recommended that stern lines be crossed to help limit lateral movement of the boat within the slip.

Electric cords and water hoses should be hooked up in such a manner so that they will not be a hazard.

The Board of Trustees approved this revised version of the Pool Rules that will be in effect in 2010. Members should review the Pool Rules and discuss them with their children to be sure they understand when they will be allowed to swim and that they must obey the lifeguard's instructions at all times.

POOL RULES

1. SWIM AT YOUR OWN RISK.
2. No swimming alone.
3. No children under 8 years old may be in the pool without a responsible person 14 years old or older in attendance and only when there is a lifeguard on duty.
4. No person under 16 years old in pool after 7:00 p.m. without accompanying adult (at least 21 years old) or when no lifeguard is on duty.
5. No swimming after 10:00 p.m.
6. Members and guests only.
7. Drinks only in non-breakable containers, except under the roof of the pavilion.
8. No running.
9. One person on diving board at a time. The next person on the diving board must wait until the person in the water has cleared the area.
10. FBYC not responsible for valuables. Club management may dispose of items left over two weeks.
11. OBEY LIFEGUARD'S INSTRUCTIONS. Anyone not doing so may be required by the lifeguard to leave the pool area.
12. "Child rest period" may be called by the lifeguard for 10 minutes out of each hour of pool operation. Children under the age of 16 must be out of the pool until the lifeguard returns to duty.

Though Dixon might make valiant efforts to protect our boats on the club docks during storms, we must all remember that it is not his responsibility to do so. His first responsibility is to take care of the club's property and facilities. The boat owners, those of us who keep our boats on the club docks and lots, are responsible for all maintenance of, security for and storm damage to our own boats.

All of the club rules pertaining to boats parked either in the One Design lot, the dry sail lot or stored wet at the club docks can be found in the back of the Sailing Events Book and should be reviewed by all affected boat owners. Other helpful information on hurricane preparation can be found at www.boatus.com/seaworthy/hurricane/default.asp. By adhering to these rules and guidelines, we should all be able to enjoy a safer season.

Winter Sailing Schedule Gets Junior Sailor in Shape for Summer Sailing Season

Hannah Steadman spent much of the winter traveling to Florida to sail with Todd Fedyszyn, OPTI National Team Coach, and Genoa Fedyszyn, coach of the St. Petersburg YC Race Team, and former US Sailing Team member. Her time with the Fedyszyns culminated at the Florida State Opti Championships March 20-21 in Clearwater, Florida.

Hannah joined more than 100 Opti sailors for the competitive, two-day event. Courses were set in the Gulf of Mexico which was a 40-minute tow from the Clearwater Sailing Center. Four races were held on Saturday in light conditions. Sunday dawned with rain and windy weather with a forecast of 25-30 knot breezes and 4-foot waves in the Gulf. The race committee began the starting sequence, which was soon interrupted by the sound of thunder from the approaching front. The race committee and coach boats all pitched in to tow the sailors back to the dock just before the front arrived with 30 + knot winds. Sailing was abandoned for the day, leaving just Saturday's races to count for the regatta. Hannah Steadman finished a very respectable 41st and got her first introduction to sailing in the Gulf of Mexico.

FBYC Junior Sailors Bring Victories to Their School

The 23rd Annual New England Secondary School Sailing Association (NESSA) New England Women's High School Championship was sailed on Sunday, May 9, at Maine Maritime Academy. Braving 46-degree temperatures and breezy, gusty conditions averaging 20 knots, Cori Radke served as one of the Tabor Academy Women's Sailing Team "A" skippers and helped the Team sail to victory. She had a convincing two firsts out of eight races (the ninth race was abandoned after a 30 knot gust was registered), bringing the team's overall score to 18 points, solidifying their victory over the other 10 teams who traveled to Castine, Maine for the Championship series. The Tabor team brought home the Rebecca Hereshoff trophy as a result. The last time the team won this trophy was 2001.

Separately, the Tabor Academy Seawolves Team Race Team, which included FBYC's Alex Jacob, won the NESSA Team Racing Championship sailing in FJ dinghies. They posted an impressive 12 wins out of the 13 race series hosted by MIT at their Charles River sailing pavilion in Cambridge, Massachusetts. The conditions were ideal with 7-15 knots and clear skies. They not only brought home the Mark Trophy, which is awarded to the winners of the NESSA Team Racing Championships, they also earned a berth to compete in the High School National Team Racing Championships in Seattle May 22-23. Twelve schools competed at the National Championships and Tabor just missed the chance to bring home the coveted Baker Trophy by finishing second behind Point Loma.


Cost for this weekend is \$30.00 for cocktails and dinner and \$10.00 for breakfast. This cruise has been great fun in the past and

YES – They form the basis for sailing which is unique compared with other sports in that we have a competitor-enforced rules system. The first statement in The Racing Rules of Sailing for 2009 – 2012 (RRS), is the Basic Principle which addresses Sportsmanship and the Rules.

Competitors in the sport of sailing are governed by a body of rules that they are expected to follow and enforce. A fundamental principle of sportsmanship is that when competitors break a rule they will promptly take a penalty, which may be to retire. This paragraph statement is sometimes overlooked in our thinking of rules but it is one of the most important rules we have.

We must first know what and where are the rules. In RRS the word

rule is a defined term and is found in the Definitions located in the back of the RRS. It states what the word Rule includes. The list is quite extensive and requires you to be up on class rules, ISAF Regulations, prescriptions of the national authority (for us that is US SAILING), and other basic things such as the notice of race, the sailing instructions; and any other documents that govern the event. In addition the definition of rules states that the definitions, the flag pictures (Race Signals), found in the back of the book, introductions, preambles, and rules of relevant appendices are all rules.

That means that you are breaking a rule when you don't follow a rule or enforce a rule and when breaking a rule you did not promptly take a penalty, which may be to retire.

NYYC Invitational Cup Qualifier – FBYC Challenge Update

The *Estimated Prophet*, FBYC's first Sonar practice boat for the NYYC Invitational Cup Qualifier, was launched for its maiden Chesapeake voyage May 17th. Eight Qualifier campaign participants got together on the spur of the moment after one-design racing was finished, and decided the *Prophet* had sat in the yard long enough – that boat was meant to be sailed, not watched.

The boat's owners generously said, "go for it", although neither were within a hundred miles of the Club at the time. A call to Dixon brought help to make sure the launch went without problems – definitely not something to try without training, as Sonars will roll sideways on the lift if not properly secured.

Rigging the boat was met with some head-scratching, as no one had ever seen a Sonar before. There are plenty of control lines (including a fine-tuning adjustment for the jib halyard), creating a spaghetti bowl at the front of the cockpit. The backstay is led to the helm/main trimmer position. Both of these controls are critical to achieving high performance and a balanced helm, and both were new tools to most on board that day.

Matt Braun, Mark Stephens, and Melissa Orndorff sailed around Jackson Creek until everyone else loaded onto the tender and towed the *Prophet* out of the creek. Mike Miller joined them for a maiden sail, and Jon Deutsch happened to be along with his camera to capture the moment, as well as his phone to post photos on the campaign's Facebook page, "FBYCCampaignfortheNYYCInvitationalCup".

Everyone was surprised at how lively the boat is. It compares closely to a J-22, which is the second type of boat that will be used by NYYC in the Qualification series. In the 8-10 knot breeze of the day, the *Prophet* was very responsive, in part because it has a large rudder compared to other small keelboat designs.

The contestants rotated places as Jon Deutsch, John and Sharon Wake, and Lud Kimbrough took a turn. It is intimidating to realize how little you know about a new class of boat. We smoothly got the chute up – well, honestly, not the first time, but eventually – and then began debating whether the jib should remain up or be dropped.

By the end of the day, everyone had a turn at the helm and in all other positions. What we learned was that it is a sensitive and highly adjustable boat, and that there is a lot to learn about making it go. Not to mention learning each crew position.
